#### Chairman's Statement For the Year Ended 31 May 2019

On behalf of the Board of Directors I am pleased to present the Annual Report and Accounts for the year ended 31 May 2019.

The result for the year is a trading profit of £19,000 (2018 - £9,000). In addition to this I can confirm that the Club's borrowings reduced by a further £239,000 during the year.

This represents my first annual 'Chairman's Statement' having taken over as Majority Shareholder and Chairman of Walsall Football Club on 29 July 2019 following the acquisition of a 76% Majority Shareholding from my predecessor Jeff Bonser.

As part of the deal that sees me take ownership of the Club, Jeff and I have agreed an 'Option to Purchase' the freehold and it is my aim to reunite it with the Club at some point during my tenure.

Jeff stepped down as Chairman and Director after a 31-year involvement with the Club with his brother Robert also stepping down as a Director of the Club at the same time. I would like to take this opportunity to place on record my thanks to both Jeff and Rob and their families for their dedicated service and contribution to Walsall Football Club over the last three decades. I have inherited a stable and financially sound Club in a continuingly difficult climate in which football clubs operate and they deserve great credit for that.

It is against this backdrop that we have been able to record a profit for the 14th consecutive year, our 23rd year of profit in the last 26 years, which is in itself a significant achievement.

Sadly however, I write on the back of a difficult season which saw us part company with then Manager Dean Keates in April and ultimately be relegated to League Two for the first time in 13 years at the end of the season. This was a real disappointment for all concerned with the Club - Players, Staff, Directors and Supporters alike.

Our stated ambition is and always has been to become a sustainable Championship club, but our immediate priority must now be to secure a return to League One at the earliest possible opportunity.

Having now relinquished many of my day-to-day responsibilities relating to my career in the Supply Chain Industry I plan to dedicate significantly more of my time to the Club to drive the business forward with the aim of achieving my stated objectives.

There is a strong platform here to move this Club forward and working alongside my fellow Directors I have already made a number of strategic changes to the business and a number of key appointments. We will continue to review all aspects of the Club on an ongoing basis in order to give us the best possible opportunity to be successful both on and off the field.

I firmly believe that on the football side of the business we have made some excellent appointments at First Team level in Darrell Clarke and his team and I am confident that the Academy is in good hands following the appointment of Miguel Llera as Academy Manager.

Furthermore, it is vital that we continue to build strong relationships with our Supporters if we are to grow and prosper. Set against that backdrop, I am looking forward to a bright future for everyone connected to Walsall Football Club.

As we sign off on another year, it is very important that we recognise the fantastic support we receive from all of our Commercial Partners and Sponsors. With that in mind I would like to offer my personal thanks to those organisations and individuals who have invested in the Club over the season and have contributed towards everything we as a Club are able to achieve.

#### 1. General information

The Walsall Football Club Limited is a private company limited by shares and registered in England and Wales under the Companies Act. The address of the registered office is given in the Company Information page. The nature of the company's operations and its principal activities are set out in the Directors Report.

#### 2. Accounting policies

### 2.1 Basis of preparation of financial statements

The financial statements have been prepared under the historical cost convention unless otherwise specified within these accounting policies and in accordance with Financial Reporting Standard 102, the Financial Reporting Standard applicable in the UK and the Republic of Ireland and the Companies Act 2006.

The preparation of financial statements in compliance with FRS 102 requires the use of certain critical accounting estimates. It also requires management to exercise judgement in applying the company's accounting policies (see note 3).

The following principal accounting policies have been applied:

#### 2.2 Going concern

The company is currently reporting net current liabilities of £1.480m (2018 - £1.210m). The directors have confirmed their intentions to provide the necessary financial support for a period of 24 months from the date of signing these financial statements. Furthermore, the directors have prepared cash flow forecasts which show that the club is able to meet its debts as they fall due in the foreseeable future. On the basis of this support and the cash flow forecasts the financial statements have been prepared on the going concern basis.

#### 2.3 Revenue

Turnover represents all income arising from the activities of the company excluding player transfer fees and Value Added Tax. Included within turnover are Football League receipts, net gate receipts, merchandising/retail receipts, sponsorship and advertising receipts, conferencing and events receipts and other income.

Football League income is recognised in full in the season to which it relates.

Season tickets and seasonal hospitality income is recognised over the season to which they relate and released over the home matches played.

Sponsorship and advertising income is recognised over the duration of the contract. Dependent on the terms of the contract this can be spread on a match to match or straight line basis.

Net gate receipts, including match day hospitality receipts, are recognised on the relevant match date.

Conference and event income is recognised on the date of the event.

Retail income is recognised at the point of sale.

### 2. Accounting policies (continued)

#### 2.4 Intangible assets

The cost of players' registrations is capitalised and amortised over the period of the respective players' contracts in accordance with Financial Reporting Standard 102 Section 18 Intangible assets other than Goodwill.

#### 2.5 Tangible fixed assets

Tangible fixed assets under the cost model are stated at historical cost less accumulated depreciation and any accumulated impairment losses. Historical cost includes expenditure that is directly attributable to bringing the asset to the location and condition necessary for it to be capable of operating in the manner intended by management.

Depreciation is provided on the following basis:

Football stadium and training - not depreciated - see below

ground

Motor vehicles - 10% to 25% straigh

Motor vehicles - 10% to 25% straight line Fixtures, fittings and equipment - 5% to 20% straight line

The assets' residual values, useful lives and depreciation methods are reviewed, and adjusted prospectively if appropriate, or if there is an indication of a significant change since the last reporting date.

No depreciation is provided in respect of the football stadium on long leasehold and the training ground. It is the company's practice to maintain these assets to a high standard and make necessary improvements thereto from time to time and accordingly, the directors consider that the lives of the assets are so long, and residual values are so high, that their depreciation would not be material and therefore is not charged in the profit and loss account. The directors perform an annual impairment review in accordance with Financial Reporting Standard 102 Section 17 - Property, plant and equipment and Section 27 Impairment of Assets, to ensure that the recoverable amount is not lower than the carrying value.

#### 2.6 Stocks

Stocks are stated at the lower of cost and net realisable value, being the estimated selling price less costs to complete and sell. Cost is based on the cost of purchase on a first in, first out basis.

At each balance sheet date, stocks are assessed for impairment. If stock is impaired, the carrying amount is reduced to its selling price less costs to complete and sell. The impairment loss is recognised immediately in profit or loss.

#### 2.7 Debtors

Short term debtors are measured at transaction price, less any impairment.

### 2. Accounting policies (continued)

#### 2.8 Cash and cash equivalents

Cash is represented by cash in hand and deposits with financial institutions repayable without penalty on notice of not more than 24 hours. Cash equivalents are highly liquid investments that mature in no more than three months from the date of acquisition and that are readily convertible to known amounts of cash with insignificant risk of change in value.

In the Statement of Cash Flows, cash and cash equivalents are shown net of bank overdrafts that are repayable on demand and form an integral part of the company's cash management.

#### 2.9 Financial instruments

The company only enters into basic financial instrument transactions that result in the recognition of financial assets and liabilities like trade and other debtors and creditors, loans from banks and other third parties, loans to related parties and investments in non-puttable ordinary shares.

Debt instruments (other than those wholly repayable or receivable within one year), including loans and other accounts receivable and payable, are initially measured at present value of the future cash flows and subsequently at amortised cost using the effective interest method. Debt instruments that are payable or receivable within one year, typically trade debtors and creditors, are measured, initially and subsequently, at the undiscounted amount of the cash or other consideration expected to be paid or received. However, if the arrangements of a short-term instrument constitute a financing transaction, like the payment of a trade debt deferred beyond normal business terms or financed at a rate of interest that is not a market rate or in the case of an out-right short-term loan not at market rate, the financial asset or liability is measured, initially, at the present value of the future cash flow discounted at a market rate of interest for a similar debt instrument and subsequently at amortised cost.

### 2.10 Creditors

Short term creditors are measured at the transaction price. Other financial liabilities, including bank loans, are measured initially at fair value, net of transaction costs, and are measured subsequently at amortised cost using the effective interest method.

#### 2.11 Contingent appearance fees

Where the directors consider the likelihood of a player meeting future appearance criteria laid down in the transfer agreement of that player to be probable, provision for this cost is made. If the likelihood of meeting these criteria is not probable, no provision is made.

### 2. Accounting policies (continued)

### 2.12 Foreign currency translation

### Functional and presentation currency

The company's functional and presentational currency is GBP.

#### Transactions and balances

Foreign currency transactions are translated into the functional currency using the spot exchange rates at the dates of the transactions.

At each period end foreign currency monetary items are translated using the closing rate. Non-monetary items measured at historical cost are translated using the exchange rate at the date of the transaction and non-monetary items measured at fair value are measured using the exchange rate when fair value was determined.

Foreign exchange gains and losses resulting from the settlement of transactions and from the translation at period-end exchange rates of monetary assets and liabilities denominated in foreign currencies are recognised in the Profit and Loss Account except when deferred in other comprehensive income as qualifying cash flow hedges.

Foreign exchange gains and losses that relate to borrowings and cash and cash equivalents are presented in the Profit and Loss Account within 'finance income or costs'. All other foreign exchange gains and losses are presented in the Profit and Loss Account within 'other operating income'.

#### 2.13 Finance costs

Finance costs are charged to the profit and loss account over the term of the debt using the effective interest method so that the amount charged is at a constant rate on the carrying amount. Issue costs are initially recognised as a reduction in the proceeds of the associated capital instrument.

#### 2.14 Operating leases: the Company as lessee

Rentals paid under operating leases are charged to the profit and loss account on a straight line basis over the lease term.

#### 2.15 Pensions

#### Defined contribution pension plan

The company operates a defined contribution plan for its employees. A defined contribution plan is a pension plan under which the company pays fixed contributions into a separate entity. Once the contributions have been paid the company has no further payment obligations.

The contributions are recognised as an expense in the Profit and Loss Account when they fall due. Amounts not paid are shown in accruals as a liability in the Balance Sheet. The assets of the plan are held separately from the company in independently administered funds.

### Multi-employer pension plan

The company is a member of a multi-employer pension plan. As there is an agreement in place with the multi-employer plan that determines how the entitiy will fund its share of the overall deficit, the company will recognise a liability for the contributions payable from the agreement.

#### Accounting policies (continued) 2.

#### 2.16 Taxation

Tax is recognised in the Profit and Loss Account, except that a charge attributable to an item of income and expense recognised as other comprehensive income or to an item recognised directly in equity is also recognised in other comprehensive income or directly in equity respectively.

The current income tax charge is calculated on the basis of tax rates and laws that have been enacted or substantively enacted by the balance sheet date in the countries where the company operates and generates income.

### 2.17 Controlling party

At the balance sheet date the ultimate controlling party was J W Bonser. From 29 July 2019 the ultimate controlling party is L M Pomlett, a director and Chairman of the club.

#### Judgements in applying accounting policies and key sources of estimation uncertainty 3.

In the application of the company's accounting policies which are described in note 2, the directors are required to make estimates and assumptions that affect the reported amount of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results in the future could differ from those estimates. In this regard, the Directors believe that the critical accounting policies where judgements or estimating are necessarily applied are summarised below.

The profit and loss reserve represents cumulative profits or losses, net of dividends paid and other adjustments.

#### 22. Pension commitments

Certain employees of the company are members of either the Football League Limited Players Retirement Income Scheme, a defined contribution scheme, or the Football League Limited Pensions and Life Assurance Scheme (FLLPLAS), a defined benefit scheme. As the company is one of a number of participating employers in the FLLPLAS, the scheme's actuary has advised that it is not possible to allocate any actuarial surplus or deficit on a meaningful basis and accordingly, no disclosures are made under the provision of FRS102. Contributions are expensed in the profit and loss account as they become payable. For the purposes of FRS102 the scheme is accounted as a multiple employer scheme. The assets of that scheme are being held separately from those of the company, being invested with insurance companies.

Following a review of the Minimum Funding Requirement (MFR) of the FLLPLAS, accruals of benefits on the final salary section of the scheme was suspended as at 31 August 1999. Since then, the Trustees of the scheme commissioned an independent Actuary's report of the MFR position and a substantial deficit was identified.

Under the Pensions Act 1995, participating employers were required to contribute to the deficiency, in accordance with an agreed Schedule of Contributions beginning on 1 August 2001 which was agreed by the Trustees and their advisers. The company's liability in respect of its share of the deficit has increased to £246,404 (2018 - £149,388) at the balance sheet date.

Contributions are also paid into individuals' private pension schemes. Total contributions across all schemes during the year amounted to £44,609 (2018 - £26,014).

### 24. Related party transactions

During the year capital repayments of £134,800 (2018 - £227,818) were made by the company against loans owed to the directors. During the year interest of £20,221 (2018 - £22,646) was charged on these loans. At the balance sheet date £1,212,882 (2018 - £1,339,165) was owed by the company to the directors.

During the year the company made sales of £18,866 (2018 - £16,199) to entities in which directors have an interest. At the balance sheet date an amount of £3,953 (2018 - £15,250) was owed to the company by these entities. During the year the company made purchases of £3,176 (2018 - £588) from entities in which directors have an interest. At the balance sheet date an amount of £720 (2018 - £300) is owed to these entities by the company.

The total remuneration for key management personnel for the year totalled £193,348 (2018 - £175,244).
